#### Presentation about SNS Advocacy Week from Sarah Elliott and Bradley Van Dam

Presented by Sarah and Brad.

List of asks:

- Additional bursaries for students from Nova Scotia demonstrating financial need.
- Mandate the testing for non-Atlantic Canadian students for the return in second semester.
- Eliminate the 31 day period needed for international students to access health plans. Change the 13 months period to a period of the first semester (4 months) to be eligible for the health plan.
- Continued expansion and investment in the CO-OP area. 50/50 pay for co-op students from employer and university to attain a 15\$/hrs rate.
- Expanding online consent module. Mandate across Atlantic Canadian universities.

#### Questions

Dhruv: Do you know what percent of the allowance money goes to international students.

Sarah: This money is only for students from Nova Scotia attending school in Nova Scotia.

Lauren: The first two grants you were talking about were Nova Scotia grants or students that attend Nova Scotian universities?

Sarah: They must be for students who are from Nova Scotia who demonstrate financial need.

Lauren: For the bursaries of Nova Scotia and the tech, were those to be allocated to the universities or to the individuals who apply? For example, does StFX get a certain number to give out or can Dalhousie students receive them all?

Sarah: No, the bursaries who go directly from the province to the students. Yes, that is a possibility.

Mike: How as the union planning to channel to the demographics that are in need? How would we make sure people who need this money get in?

Sarah: Yeah, the money right now is being primarily allocated to students on student assistance, so people who cannot pay for their schooling.

Bradley: The needs would be accessed by the province and through the application process.

Henderson: The student assistance bursary is for all students or students from Nova Scotia?

Sarah: This one is just for Nova Scotia students attending Nova Scotia universities.

#### Presentation from the Golden X Inn Renovation Committee

Presented by Sean Ryan and Brendan Roberts

Sean: Should it be a 25\$ fee or 50\$ fee? Students feel more comfortable at 25\$, but with 50\$ the project could move forward much faster. The committee needs help from council to decide and iron out that detail.

Passes piece of paper to amend the agenda for the next meeting determining 25\$ or 50\$ fee amount.

Sean: If the referendum is passed, the project could start the patio construction during the summer of 2021. The bulk of the interior would be done once graduation ends in 2022.

Sean: We were given back 40,000\$ from heath care provider, how to manage the money? The rebate amount back to students would not be very much. Therefore, the idea came to create a Student's Union StFX health and wellness grant program, similar to emergency grants.

Sean: Of course, but there are inevitably gaps and health care providers that we will try our best to cover.
