Naomi: I would like to begin by acknowledging that we are in Mi'kma'ki, the ancestral and unceded territory of the Mi'kmaq People. This territory is covered by the "Treaties of Peace and Friendship" which Mi'kmaq and Wolastoqiyik (Maliseet) peoples first signed with the British Crown in 1725. The treaties did not deal with the surrender of lands and resources but in fact, recognized Mi'kmaq and Wolastoqiyik (Maliseet) titles and established the rules for what was to be an ongoing relationship between nations.

- Volunteered in the Golden X Inn's promotional video recently released on their social media.

- Attended a society conference in Saint John, NB, from March 4, until March 6. Contacted President Andy Hakin on supporting Ukraine, a sovereign state, against Russian aggression, invasion, and war crimes. I urged President Hakin to fly the Ukrainian flag on campus at Alumni Plaza to publicly display our support for the free and innocent people of Ukraine. The flag-raising ceremony means a significant amount to me because my heritage is Ukrainian Mennonite. During the early twentieth century, my family escaped the Odesa region of present-day Ukraine from Russian tyranny. They fled to Canada following my great-great-grandfather, Peter Frank Kroker, getting his ear sliced off while standing up for his people and family's livelihoods against the Russian military. My family was jubilant to see the collapse of the Soviet Union in 1991 and had great hopes that our ancestral homeland would be free and sovereign. Today, that hope is crumbling, and despair is slowly sinking in. However, please join me in supporting the free people of Ukraine and rallying around their cause against senseless Russian aggression.
