Student Union President

- Annual plan retreat happened- plan is soon to be released.
- O-Week and Mulroney event planning is happening.

Committee Reports

Governance Review Committee

- Have been meeting biweekly
- Trying to coordinate with governance experts to get training for council
- Draft Act of Incorporation from lawyer has come in, once approved by council will be circulated among students for feedback.
- Considering formats for in person consultation from students
- Made list of everything concerning about policies and by-laws, will be tackling this once school starts.

Special Reports to Council

Peer Support Program Presentation:

Presentation given by Emma and Suzanna

- Both gave their personal reasons for starting this program, mainly coming from their experience during first year with the lack of support for people struggling with mental health. The idea was developed to provide support for people who need someone to talk to during hard times, when they are not comfortable approaching close friends or adults for this support. It is especially important for first years, who might not know many people on campus, and are struggling being away from home for the first time.
- Service created to provide listening service and guidance to all students by trained students. The intention is to help and direct students towards some of the many resources the school has for outreach. The idea is to be the first listening ear for students who aren't comfortable talking to somebody else, but would like to talk to someone.
- **Goal:** to increase awareness and use of resources on and off campus that assist with mental health, as well as increase knowledge of mental health around campus.
- Will exist as a service under the Student's Union, overseen by VP Finance and Operations.

- Will address general mental health, as well as more specifically support for problems caused by sexual violence or assault.
- Intended to fill the gap for people who need mental health support, but don't know how to get it.
- Trained student councilors will greatly benefit the student body, especially first years and students who do not wish to officially report any incidents that occurred.
- Benefits come from the personal service to students.

Addressing concerns:

- Confidentiality: Steps that will be taken to ensure confidentiality will include the training of volunteers, soundproofing of offices, immediate dismissal of volunteers who break confidentiality, and limited access to information.
- Crisis Situations: Councilors will be trained to know when it is legal and necessary to break confidentiality, knowledge of emergency services, and on call shift leaders.
- Support for Program: Ties to Student's Union, committed faculty support, and relationships with resources.
- Funding: Comes from StFX Strong member donations.
 - Costs: \$750 for insurance, with added operating costs. Training will be donated for free.
- Intend to work together with Student's Union, and accept continuous feedback from the council, especially during upcoming pilot phase.

Motion to suspend rules of procedure and make an informal space during question period.

Motion Passes 9-0-0

- January start for pilot (opposed to September) due to late approval and time needed to recruit volunteers and schedule training. Time will also be used for promotion and awareness of upcoming opening.
- System in place to provide support to volunteers who may feel burdened (shift leaders, faculty support, health and counselling, extra spaces, self-assessments, end of shift reports.)
- Shared experience defined as student living and getting an undergraduate degree in the same campus.
- Success = 15 visits a month

Presidential Hiring Presentation:

Presentation given by Tiffany

- Survey on what students want in a new president (intended to engage people not on campus during the summer) has gone out and closed.
- In person consultations go from September 16-18.

BA Restructuring Group Presentation:

Presentation given by Marc.

- Working with Dean of Arts.
- Goal: Align with different things that other universities, (specifically Ontario schools), have been offering to BA students, such as co-ops, elimination of mandatory minors, and changing how major pairs work. Essentially want to add more flexibility to the degree.
- Looking at following a Breath model (expanding degree with more diverse mandatory electives).
- Execs and council are asked to review short survey for feedback before it goes to general students. They are looking for more students' points of view.
- Looking to add more people onto the committee (Emma, Tiffany).

Act of Incorporation:

William moves to go in-camera, as council is to discuss legal work.

Cecil seconds the motion.

Motion passes 9-0-0

Council enters an in-camera session for the duration of the presentation

New Business

Emma: Motion to approve a one-year pilot project for the 2019-2020 academic year for the Peer Support Program as presented.

Discussion:

Patrick: As this project falls under VP Finance and Operation office, support is expressed for this along with other student support programs.

Tiffany: Supportive of the idea and pilot but wants more discussion throughout the year on the actual progress and success of the project through the pilot.

Cecil: Wants to focus on measurable success, as well as communication between VP Finance and project.

Gallery (Clayton- Gender and Sexual Diversity Advisor for StFX): Partner with the program, and has already agreed and is eager to provide the support and training for volunteers of Peer Support. Stresses the importance of mental health services for the queer student community.

Gallery (Maureen- Professor in English Department): Expresses high admiration for the particular program proposal made for the Peer Support Program, especially compared to the programs at other universities. Suggests measuring volunteer training, as students trained in these skills will better the campus community.

Marc: Congratulations to Emma and Suzanna on a great program creation and lots of hard work.

Motion Passes: 8-0-2
