# Special Reports to Council

### **University Financial Update: Andrew Beckett**

Last Year (2018/2019):

- Fiscal year ends March 31
- Budget was in deficit of 3.2million, then ended the year in a surplus thanks to approval for additional funding from the province.
- Student fees came in over budget.
- Additional revenue brought in from Shwartz.
- Scholarships have been significantly over-budget, due to more students qualifying for academic scholarships, and more students maintaining their scholarships.
- Infrastructure has become very expensive to maintain, but that money needs to be spent.
- Not enough students interested in residence, so we are promoting residence for second year.
- Coady lost \$5.2 million, due to the ending of program with federal government.

## This Year (2019/2020):

- 'Break-even budget', one with a small surplus.
- Projecting to end in a small deficit, due to government grant with a lower raise than expecting.
- Exceeding expectations for student enrollment.
- University has signed agreement with province for a minimum 1% increase in funding annually.
- Working towards international recruiting.

• Sitting on large accumulated deficits.

#### General Updates

- Mulroney Hall is open but will not be finished for several months.
- Nicolson Tower is nearly finished.
- Alumni Plaza is not yet finished.
- Have improved varsity locker rooms, as well as the installation of visiting team locker rooms.
- Changes over the summer with food contract, Bloomfield Café has been renovated and the campus Starbucks is up and running.
- Twelve in Mulroney hall has opened.
- The roof has been replaced on the Physical Science Building, and leaks have been taken care of.
- Working on IT security and security awareness for users.
- Working on risk management and occupational health and safety, especially in labs. Audits have been done of lab spaces and there is a program in place to increase safety.
- Working on emergency preparedness, especially after hurricane Dorian.
- A new VP of students will start January 6, 2020.
- Hoping to have new sexual violence policy in place January 1<sup>st</sup>, 2020.
- Created a new space for Indigenous students on campus, an official opening will be coming soon.
- Getting new furniture for the Diversity Engagement Center.
- Discussion about campus culture and student experience.

A question arose from the gallery about the problem of mold and unclean water found in Bishops residence. The gallery member also mentioned problems a victim of sexual assault had with Safety and Security not enforcing the ban of the assaulter from the residence. Concerns were expressed about the extended length of time it took to ban the assaulter from the building, as well as the actual practices the University was following to handle situations like these. Beckett expressed concerns and ensured this situation will be investigated. As this conversation was not scheduled in the agenda, it had to be paused to be continued at another time.

## Students NS Overview: Clancy McDaniel, Sarah Elliott

- **Students Nova Scotia:** A registered non-profit organization, which partakes in student advocacy to the provincial government.
- They do not take ideological stances. Founded in 2003, the organization is democratic, and member driven. Cecil and Sarah vote in this organization on behalf of St.FX students.
- They raise awareness, sit on internal committees, find solutions for student issues, host conferences, and much more.

- Each student association has 2 voting members, representing about 20 000 students across the province.
- Works to implement different initiatives through the provincial government. The most recent one is an imitative to regulate funding to post-secondary education.
- Identify student issues at conferences and develop annual plans and strategic plans.
- Do research to ensure solutions brought to government are thorough and complete, so they lead to more success.
- Engage in advocacy and lobbying. They provide a public face to student issues and advocacy.
- Student issues vary, and focus on affordably, accessibility, and equality. Each year a few issues and chosen to specifically focus on.
- Advocacy is public support for certain issues.
- Lobbying is an attempt to influence the government.
- Meet with many government figures who hold the power to improve student life.
- In 2018 the government took direct recommendation to invest money into post-secondary mental health and co-op education.
- In 2017 we were mentioned by name in the budget address, having lots invested into student financial aid.
- In 2019 annualized investments were made into mental-health and sexual violence prevention.
- More recently have been advocating for free healthcare for international students.

It was noted that this information is also all accessible on the Students Nova Scotia website.

## **Mental Health Initiative: Sarah Elliott**

- Attended a conference with the Mental Health Commission of Canada.
- Introduced a new standard of how much help is given for student mental health need, that will hopefully soon be implemented nationally.
- Looking for student consultation on this new initiative, done through Mental Health Commission website.

#### **New Business**

Tiffany: Motion to approve the proposed amendments to the StFX Students' Union Act of Incorporation.

Nick: Second.

Discussion was had about the lack of mention of Coady students in the Act, and it was clarified that Coady students could be included in the by-laws.

Johanna: Motion to change the phrase 'him or herself' to the phrase themselves.

Amendment was friendly.

William: Motion to change article 11 to reflect our constitution, and motion to replace the word 'proposed', found in section 8, with the word 'propose'.

Both amendments were friendly.

Emma: Call to question.

Motion Passes 13-0-0.

Jasonique: Motion to ratify Emma Waller as Student Advocate 2019-2020.

Emma: Second.

Discussion was had to express that Emma was a great pick for the job. She was not the only applicant, and was very prepared.

Motion Passes 12-0-1.

Jasonique: Motion to ratify Societies omnibus.

Nick: Second.

Discussion was had in reference to some societies having unrealistic numbers in their applications. This is usually an unrealistic amendment percentage.

Tiffany: Motion to amend the society list to remove 4 societies for the reason of unrealistic numbers, including the International Student Society, the St.FX Vegan Society, the St.FX Dance Team, and the Math, Stats and Computer Science Society.

Todd: Second.

It was clarified that these societies can be amended in the future, as long as they amend their constitution to include more realistic numbers.

**Motion Passes** 

It was brought to councils' attention that X-Pride society has a conflict of interest included in their application.

William: Motion to remove X-Pride from the current list to be ratified.

Kamy: Second.

More discussion was had about the ratification of X-Pride. Councilors discussed the reasons that may have been behind this apparent conflict of interest, as they had given good reason for their process being outlined as such. The constitution under article 5 reads: "Any officer of the executive of the society may be impeached as long as over half of the executive supports the motion for impeachment. The motion needs to first be discussed with the GSDA (Gender and Sexual Diversity Advisor)."

The option was discussed to have a member of X-Pride attend the next council meeting to clarify this section of the constitution.

It was noted that X-Pride is a longstanding society, and that it could be in the councils best interest to realize that their constitution was very well written and included this form of impeachment for a reason, being they have the necessary supports to follow through in a proper way.

It was noted that this is the first year X-Pride has its own written constitution.

It was noted that if the X-Pride society is not ratified this meeting, the group will not be able to qualify to apply for the funds needed to host their very positive annual upcoming event: 'Sex Toy Bingo'.

Discussion was had about letting judgment as individuals reflect on the decisions of council and official council actions.

Discussions were had about possible changes that could be made to this constitution, such as lowering the percentage of execs needed to impeach someone or adding a few students at large.

Cecil: Motion to conduct this vote by secret ballot.

*Motion to vote by secret ballot fails 4-8-1.* 

Tiffany: Call to question on amendment.

*Motion to amend to remove X-Pride fails 3-6-4.* 

Tiffany: Call to question.

Jasonique: Motion to ratify the list of societies omnibus as amended.

Nick: Second.

Motion passes 12-0-1.
